### APRIL, 2019

1. Mr. Kelsang Dhondup took over as the new Executive Director of Active Nonviolence Education Center, replacing Miss Tenzin Lhamo who has served for three years both as a trainer as well as Executive Director. Active Nonviolence Education Center also appointed new trainer Mr. Ngawang Lungtok replacing former trainer Mr. Thupten Choephel. Hand-over of ANEC Important documents, all files, teaching gears, books, kitchen stuffs, office furniture, electronic items, computers and other related items



- 2. New Executive Director called a meeting with all the staffs of ANEC to inform each staffs responsibility and share their experience.
- 3. ANEC hosted farewell dinner to the outgoing Executive Director Miss. Tenzin Lhamo at Hotel Tibet and Staffs along with ANEC Board Members were also present at the farewell dinner



MAY, 2019

2. Welcoming new staff Mr. Ngawang Lungtok for the post of Assistant Trainer. Handed Assistant Trainer job description file.

3. Michael Litting from USA visited ANEC office; Mr. Litting is briefed about ANEC and its activities and contact are exchange for future meeting.

4. Meeting with TCCR Director Mr. Karma Lekshey at ANEC office for almost one hour on various matters including trainer's workshop. The meeting was successful.

- 5. To arrange a meeting with Prof. Samdhong Rinpoche, Executive Director met with Mr. Urgen Tenzin for an appointment with Mr. Dhonyoe, Personal Assistant to Prof. Samdhong Rinpoche.
- 6. ANEC office staff weekly meeting held, office secretary cum accountant Mr. Jigme briefed each staffs' of their responsibilities, leave procedure. We concluded that Mr. Ngawang Lungtok assistant trainer to attend Delhi WED workshop. Proposed ideas regarding staff medical insurance policy and possible permanent staff of ANEC.

- 9. ANEC staff weekly meeting held on Monday. Discussed weekly report, fund raising strategies, emails from two volunteers from Assam, newsletter, recruiting new staff when Jigme (office secretary cum accountant) leaves, ANEC website and Facebook update, membership form.
- 10. Meeting with Prof. Samdhong Rinpoche with all ANEC staffs at his resident. Three main agenda

discussed. One, talk by Rinpoche on selective audience on what ANEC should teach our young generation from Buddhist perspective and second, requesting Rinpoche to be Advisory to ANEC and third, Requesting Rinpoche to be member of ANEC Honorary Membership. Rinpoche la has accepted all our appeal

11. Meeting with Jigme about Project Proposal. Mail and call to Sherig (Department of

Education) requesting a list of Tibetan schools within India and Nepal. Since their concern staff engaged with ongoing workshop for school administrators, they promised to send by coming Monday.





- 12. Finalized budget proposal sent to Tibet Fund (A month Workshop and Brainstorming on moving forward with Nonviolence Principal and Practicalities to Tibetan Community Leaders.) from Executive Director Mail ID.
- 13. Jigme went to Imperial printing press to design visiting card for the ANEC staff. The same day handed over all visiting cards to the respective staffs.

#### JUNE, 2019

- 1. Official meeting with Mr. Gyaltsen from Tibet Fund project officer based in Dharamshala regarding ANEC fund, Project proposal, collaboration project with DOE and other related matters.
- 2. Executive Director corresponds with Mr. Tsewang Phuntsok Latin America Representative and Geshe Jamphel Khantse in Taiwan through Facebook regarding ideas and work.
- 3. Assistant trainer Mr. Ngawang Lungtok attended training of trainers organized by Women's Empowerment Desk and Martha Farrell Foundation.

Women's Empowerment Desk, Central Tibetan Administration and Martha Farrell Foundation together organized training of trainers to trainers from different NGO's to teach about Gender based violence and safe workspace. It was a five day intense training that started usually from 9:00 in the morning and lasted till 7:00 in the evening. Our assistant trainer went to particularly learn their training methodology(which was mainly participatory) meanwhile also



learnt a lot about gender based violence and know how in situations. Most of the NGO's were from ones that focused on gender violence.

4. Official meeting with Dr. Pema Yangchen, Kalon of Dept of Education at her office. Briefed Dr. Pema Yangchen on ANEC and its work. Requested her to become honorary member and

governing board member of ANEC. But it won't be possible because those serving in CTA aren't allowed to register with NGOs. Also requested assistance and collaboration in publishing a book based on Prof. Samdhong Rinpoche talk (which will be held soon). Made an appeal for support from Department of Education when organizing workshops and trainings in Tibetan Schools



- 5. Appointed Mr. Kunga Soepa, B.COM and MBA background on trial basis since Jigme current accountant is soon leaving his job, as he will be immigrating to Australia under Political prisoner program soon. In order to get know about ANEC office day to day work he works with Jigme for a month.
- 6. Confirmed Norbu House as venue for Rinpoche's talk and requested video recording of Rinpoche talk to Mr. Pema Tsering, freelance and photographer.
- 7. ANEC His Holiness the Dalai Lama birthday message given to Tibet Times to publish in the coming week.
- 8. Executive Director met with Namgyal Monastery School Principal on following points
  - Messages of His Holiness the Dalai Lama on Nonviolence
  - To write down Rinpoche's talk
  - To get firsthand information on Nonviolence Movement inside Tibet in 1987-88-99.
  - CD of Nun's sang song in prison in Tibet.
- 9. Geshe Ngawang Dhargyal of TCV accepted to be one of the Geshe's during Rinpoche talk.

#### JULY, 2019

- 1. ANEC organized two days membership drive (5th and 6<sup>th</sup> July). During the drive, staff distributed magazine and brochure near Namgyal Monastery gate. Since there will be plenty of
  - people attending the long life ceremony of Dalai Lama, we(ANEC) thought it would be nice opportunity to have our membership drive there. Everyone together, we were able to recruit some members. And it was also His Holiness birthday on 6<sup>th</sup> July.
- 2. Met Mr.Tenzin Phuntsok Atisha former DIIR office secretary and asked about DIIR Nonviolence Desk. Atisha arranged meeting with Taiwan Nonviolence Group next day.



- 3. Executive director and Secretary met Taiwan Permanent Peace Partner Members at Choenor Guest House, presented ANEC Brochure and News Letter. Also introduce ANEC to them. Secretary went to printing press to print poster for the upcoming Rinpoche talk.
- 4. Send invitation letter to all the organization in and around Dharamshala for the upcoming Rinpoche talk on 15<sup>th</sup> July.

5. On 15<sup>th</sup>, July we had a successful talk by His Eminence Prof. Samdhong Rinpoche for 3 hours on Non-Violence through Buddhist perspective at Norbu House. And also Prof. Samdhong Rinpoche inaugurates our membership drive being the first member of ANEC (Honorary). The talk attended by

around 40 people from different organization. After the talk, invitees were given the opportunity to ask questions and later, forming into groups had a space for discussion. Member from each group were also given the opportunity to put forth their group's point of view. And it was grand success.
6. Day after the talk Executive Director got call from VOA( Voice of

America) for the interview about ANEC and the Rinpoche program.

7. Half day workshop was arranged to summer camp students (Tibetan children settled outside India mainly North America and Europe) at TCV with introduction note by Executive Director. Later trainers taught the concepts of



nonviolence and violence to them. The worldview through which we (Tibetans) look at nonviolence and nonviolent action is very Buddhist. Tibetans view nonviolence as a discipline we can maintain rather than as a weapon we can wield against our opponent. As far as tactical use of methods are concerned. Tibetan have been majorly using methods that fall under the category of "Protest and persuasion" as defined by Mr. Gene Sharp, pioneering theorist in nonviolent methodology.





8. Active Nonviolence Education Center visits Sikyong Lobsang Sangay at his office. Executive Director along with secretary cum accountant had a very thorough discussion with Sikyong on various issues regarding both ANEC and Tibetan cause at large



- 9. Financial help and appreciated the work done by ANEC. Executive Director Send letter to Mr. Tenzin Kunga, London Representative for connecting ANEC with BBC Hard Talk Producer and Tenzin Kunga agreed to connect ANEC with BBC producer. Letters send to Tenzin Dorjee requesting to connect ANEC with ICNC Director.
- 10. Amche Pelmo, a nun from Ladakh requested ANEC to give workshop in October. But later postpone to next year due to changed in political set up in J&K.
- 11. On the morning of 17<sup>th</sup> July 2019, Executive Director met with Taiwan Permanent Peace Partner founder Mr. Chien-Ming Huang, Taiwan and discussed the work ANEC do here. Finding similarities in achieving a nonviolent society and world at large, PPP decided to support our endeavors



## AUGUST, 2019

- 1. ANEC had weekly presentation session for both of our trainers in order to get more practice and be more confident in future workshops and program.
- 2. Prepare financial statement for the year 2018-2019 and referred to Mr. Tsering Dhondup, (former Finance Minister) ANEC accounts related advisor. And made some correction regarding books of accounts.
- 3. New Printer Installed at secretary desk and old printer replaced since it was not functioning despite repairing it. And also new Hard disk of 1000 GB Bought and then upload Prof. Samdhong Rinpoche Talk and documents to be saved.
- 4. Quotation collected for backup batteries and inverter, sent proposal to Mr. Lobsang Nyendak of Tibet Fund and luckily he accepted and granted the budget for buying battery and inverter. Because the electricity around here is frequently breaks down and sometimes the electricity is turned off for several hours in a very stretch. It leads tremendous technical problems and by which it causes delay in carrying out our ongoing works. Finally bought the battery and inverter and electrician installed the battery and inverter. Now there is no problem regarding shortage of electricity.
- 5. Executive Director requested Geshe Ngawang Sonam, who works at translation section in Dalai Lama private office to take class on Buddhist perspective through nonviolence. Accordingly ANEC organized 1st hour talk for the anec staff on anger management which is extracted from Buddhist script "Boddhicaryavatta". It started from 21<sup>st</sup> to 26<sup>th</sup> august by Geshe Ngawang Sonam at his resident.
- 6. Meeting with Kasur Tsering Dhondup (former finance minister) Anec accounts related advisor, at his office, introduce our new ANEC director and accountant cum secretary. Discuss related with FCRA and financial statement.





## **SEPTEMBER, 2019**

- 1. Anec staff meeting on Monday morning is conducted as usual wherein we meet to discuss what more need to be focused and done in the coming days and review the previous week work.

#### OCTOBER 2020

1. On 2<sup>nd</sup> October 2019 to mark the birth anniversary of Mahatma Gandhi, ANEC organized a talk on Nonviolence to 70 odd students from Upper TCV class XI and XII. The facilitators were Geshe Ngawang Sangye la, Rev.Ngawang Woebar la and ANEC Executive Director. The aims and objectives of the session is to educate students on nonviolence and to create awareness about Buddhist perspective on Nonviolence by citing verses from Shantideva's*Bodhisattvacaryāvatā*(or the Bodhisattva's Way of Life)



2. 5<sup>th</sup> October 2019, ANEC organized a half day talk on the topic"Apology" led by Daniel from Global Inner Fitness Group and was attended of two NGO's TCCR and Tibet Action Institute. The methods included trust, safety, acknowledgment, consideration, and impact. He then stressed the importance of keeping our inner child happy and safe so that our outer demeanor doesn't resonate and reflect violence because he thinks if we keep stuffing things inside us that aren't healthy, we will automatically react violently outside to smallest of problems or confrontation.

The camp covered a range of workshops from deconstructing nonviolence as a tool of resistance to campaignorganizing, grassroots outreach, media and messaging, public

of participants. Trainers and facilitators employed informal teaching methods, using games, group exercises, and trust games to enable each participant to step outside their comfort zones and discover the leader in them.
